Daily Balance Method- We use the daily balance method to calculate the interest on your account. This method applies a daily periodic rate to the principal in the account each day.

**After maturity if you choose to roll over your CD, the 6-month term will be rolled into the 6-month term and 11-month term will be rolled into the 12-month term, and 18-month term will be rolled into the 18-month term and will earn the rate of interest in effect at that time.
